Notes on data protection

Lawfulness of processing

This is based on Art. 6 para. 1 sentence 1 lit. b) GDPR. Furthermore, data processing is permitted for the fulfillment of a legal obligation pursuant to Art. 6 para. 1 sentence 1 lit. c) GDPR or for the enforcement of our legitimate interests pursuant to Art. 6 para. 1 sentence 1 lit. f) GDPR.

By entering into a business relationship as an interested party, supplier, customer or business partner, we will store your contact details and information about business processes and communication with you and process them at least for the duration of the business relationship.

Your personal data will be passed on to third parties if this is necessary in accordance with Art. 6 para. 1 sentence 1 lit. b) GDPR for the implementation of pre-contractual measures and fulfillment of the contract with you. This includes in particular the transfer to suppliers, subcontractors, etc. The data passed on may only be processed by the third parties for the stated purposes.

The data will be deleted as soon as it is no longer required for the aforementioned purposes. However, we store your personal data for as long as we are legally obliged to do so, for example due to retention obligations or limitation periods for potential legal claims that have not yet expired.

Your rights

You can obtain information from us at any time about your stored personal data (Art. 15 GDPR), request its rectification (Art. 16 GDPR), erasure (Art. 17 GDPR) or restriction of processing (Art. 18 GDPR) and assert your right to data portability (Art. 20 GDPR).

If your personal data are processed on the basis of legitimate interests pursuant to Art. 6 (1) sentence 1 lit. f) GDPR, you have the right to object to the processing of your personal data pursuant to Art. 21 GDPR, provided that there are reasons for this arising from your particular situation.
